Notes from the April 17, 2008 Meeting

4. Maintenance Issues - Marge
  - a. Wood chips update

Marge reported that she could find nothing in writing from the contractor on how long the wood chips were supposed to last. She has received information from

another source in New Egypt, New Jersey, who gave her a quote for substitute pine chips which would run approximately \$1,523 for about 200 bags including delivery. Susan suggested that Marge post this information to everyone by e-mail so a decision could be made authorizing her to proceed as the chips in the park have deteriorated in certain areas to an emergency level. The consensus of those present was that the deterioration may have been caused by increase in park usage.

b. Fence painting

The consensus of those present was that if the fence were to be painted, the park should be closed for a sufficient amount of time for the paint to dry and it was decided to discuss this at the next meeting. Marge has the black paint.

c. Other - Marge is planning to have the Borax placed down again and Susan suggested that a written notice be posted 3 days prior.
